Nurse co-owners Kaye Pegelow and Pam Mace-Murray have run it since the 1997 founding. 4.5-star CMS quality, solid volume, Fredericksburg MSA. A textbook succession conversation.

3 Blue Ridge Home Health Care

Galax, VA · CMS ~1,419 · Cert. 2009 · CMS ★ 1.5 · high confidence

The site calls it a private, independent agency, and founder Dustin H. Snow is CEO and administrator. Strong volume for rural SW Virginia. Low quality star (1.5), so clinical diligence comes first.

5 HealthView Home Health & Hospice

Rocky Mount, NC · CMS ~810 · Cert. 1973 · CMS ★ 2.5 · med confidence

One of the few true independents in a certificate-of-need state. Home health plus hospice, with a CEO / registered-agent signal on C. Saunders Roberson Jr. Confirm SOS members and any capital partners early.

2 1st Care At Home (Commonwealth Home Health)

South Boston, VA · CMS 200+ staff · Fd. 1985 · cert. 1985 · CMS ★ 3.5 · high confidence

Veteran-founded in 1985, now third-generation under owner Trey Burkholder. 200+ staff and two Medicare CCNs across Southside VA and Lynchburg. Clear principal, clear geography; the angle is scale or partnership, not retirement.

4 Hallmark Home Health Care

Danville, VA · CMS ~477 · Cert. 1993 · CMS ★ 3.5 · med confidence

Danville agency, Medicare-certified since 1993; its site says independently, locally and women owned. Mid-small volume, 3.5 stars. Owner isn't named publicly, so pull SCC officers before the call.

How we sourced this

- CMS Provider Data Catalog (every Medicare-certified VA and NC agency, proprietary filter), Medicare Care Compare, NC DHSR licensure lists, NPI registry records, company pages and local press.
- Volume = CMS timely-care denominator, a workload proxy only (not census or revenue). Medicare cert. = CMS certification date for the agency's CCN; founding year shown only where the company or press states it.
- NC's certificate-of-need rules keep true independents scarce, so the NC count is small by design, not padded.
- Owners are named only from public records; contact details are held back for the paid sheet.
